"We encourage research into the field of environmental sensitivities, exploring the many causes, diagnostic methods, and etiologies that would seem to be involved. However, we do not feel that our support for more research should be interpreted as a reason to hesitate in providing, to physicians and the public, what information is already available, using diagnostic and treatment methods already recommended by government studies and reports, and taking such basic steps as providing reasonable accommodation for this disability in health care facilities, or respecting the needs of children with this disability in schools."
